Congress 2012 Terms and conditions

- All payments are in Australian dollars (AUD) and include 10% GST.
- Registration forms must be accompanied by payment.
- Registration is not transferable and a congress registration is for one individual. The provided name badge must be worn at all times during congress.
- All cancellations of event registration must be in writing and forwarded to Home Economics Victoria.
- IFHE World Congress registration cancellation requests received until 4.30pm (GMT +10) 16 April 2012 will be refunded except for an administration fee of 20% per participant.
- Cancellation of IFHE World Congress registrations received after 16 April 2012 cannot be refunded. 'No-shows' will not qualify for refunds.
- Payment can be made via VISA, MasterCard or electronic funds transfer (EFT). Australian registrations also have a cheque or money order option.
- All payments made by EFT must include all bank charges to be made by the transmitter.
- To register at the **student price**, registrants must be full-time undergraduate students at the time of registration.
- Students must provide a photocopy of their current student ID card with their registration form.
- To register at the **accompanying person price**, registrants must be a partner or family member of the registrant.
- By selecting a **member registration price**, it is agreed that the registrant is a current financial member of IFHE (or Home Economics Victoria or HEIA for Australian packages).
- All social events require payment of a reservation fee and presentation of ticket at event.
